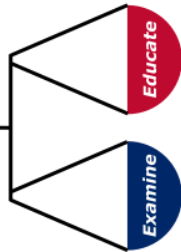

LONG TERM GOALS:

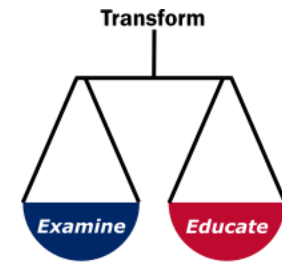
- Promote Personal Transformation of Members of the Community
